

This guarantee shall be valid up to 08.03.2020 (excluding claim period) from the date of expiry of the Defect Liability Period.

Notwithstanding anything contained herein:

Our Liability under this Bank guaranty shall not exceed Rs. 22,65,500/-This Bank Guarantee shall be valid up to 08.03.2020.
