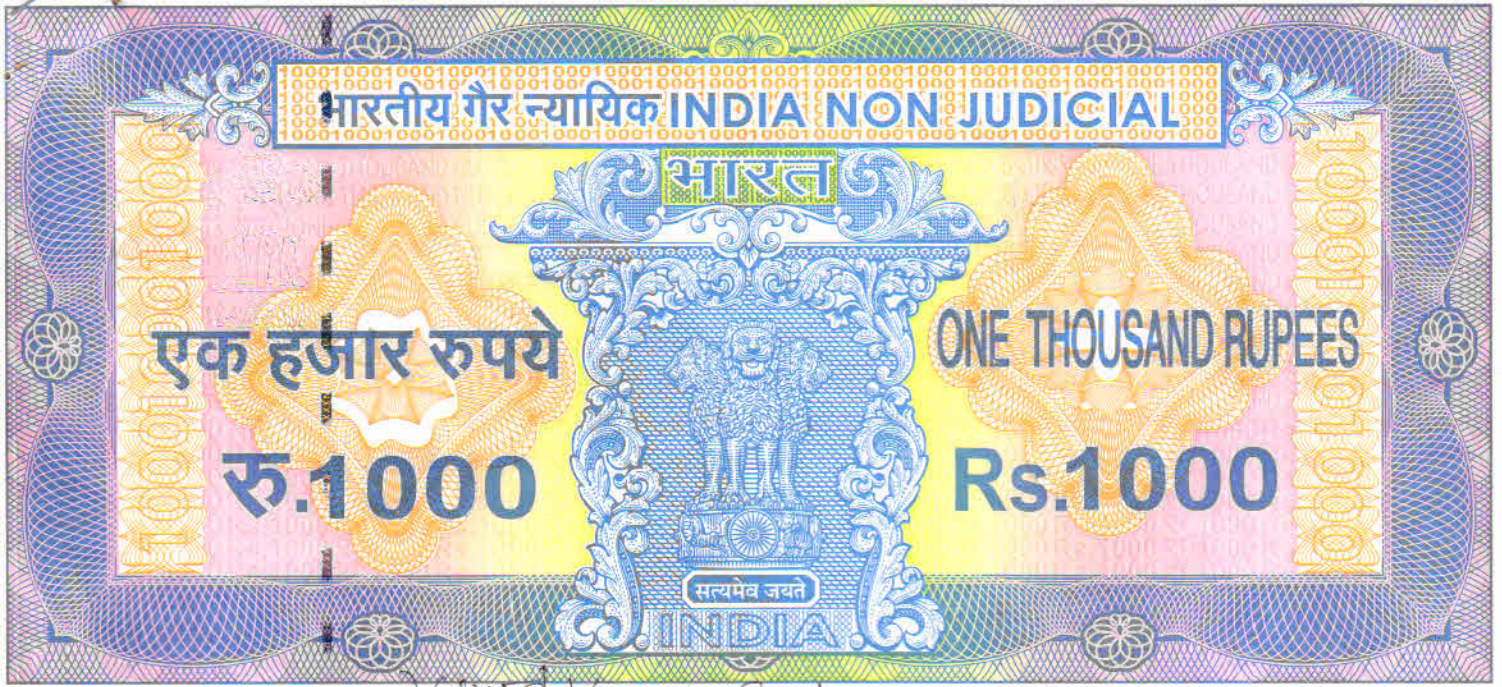

The guarantee will not be revoked during its currency without the prior consent of the beneficiary.

We hereby waive the necessity of your demanding the said debt from the Contractor before presenting us with the demand.

We further agree that no charge or addition to or other modification of the contract or of the works to be performed there under or of any of the contract documents which may be made between you and the contractor shall in way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition of modification.

This Guarantee shall be valid upto 07.03.2020.

Not with standing any think contained herein:-

- (i) Our liability under this Guarantee shall not exceed Rs. 8,21,000/- (Rupees Eight Lakh Twenty one Thousand only).
- (ii) The Guarantee shall be valid upto 07.03.2020.
- (iii) Our liability to make payment shall arise & we are liable to pay the guarantee only if you serve upon us a written claim or demand in terms of the guarantee on or before 07.03.2020.

The guarantee is to be returned to us within 15 days from validity period. If the guarantee is not received back by us within that date it shall be deemed to be automatically cancelled.
