

# INSTRUCTIONS

- Record of transactions for the information of the depositor and balance shown in it cannot be withdrawn.
- The depositor of the passbook from the concerned post office and the post office is legally liable to pay the amount actually shown in its record.
- The depositor should take a printed receipt from the post office when handing over the passbook to the post office for any purpose.
- Always keep the passbook in your personal custody and the post office will not be responsible for any loss of money in case the passbook is handed over to any other person.
- Do not keep specimen signatures in the passbook.
6. Check balance after transaction written in the passbook and contact postmaster immediately in case of any discrepancy.
7. In case of loss of passbook, report the matter in writing to the postmaster immediately.
8. Intimate change of address if any to the postmaster.
9. Don't hand over blank signed withdrawal forms to any person including authorized agents.
10. Do not appoint postmasters or authorized agents as messengers for withdrawal of money from your account.
