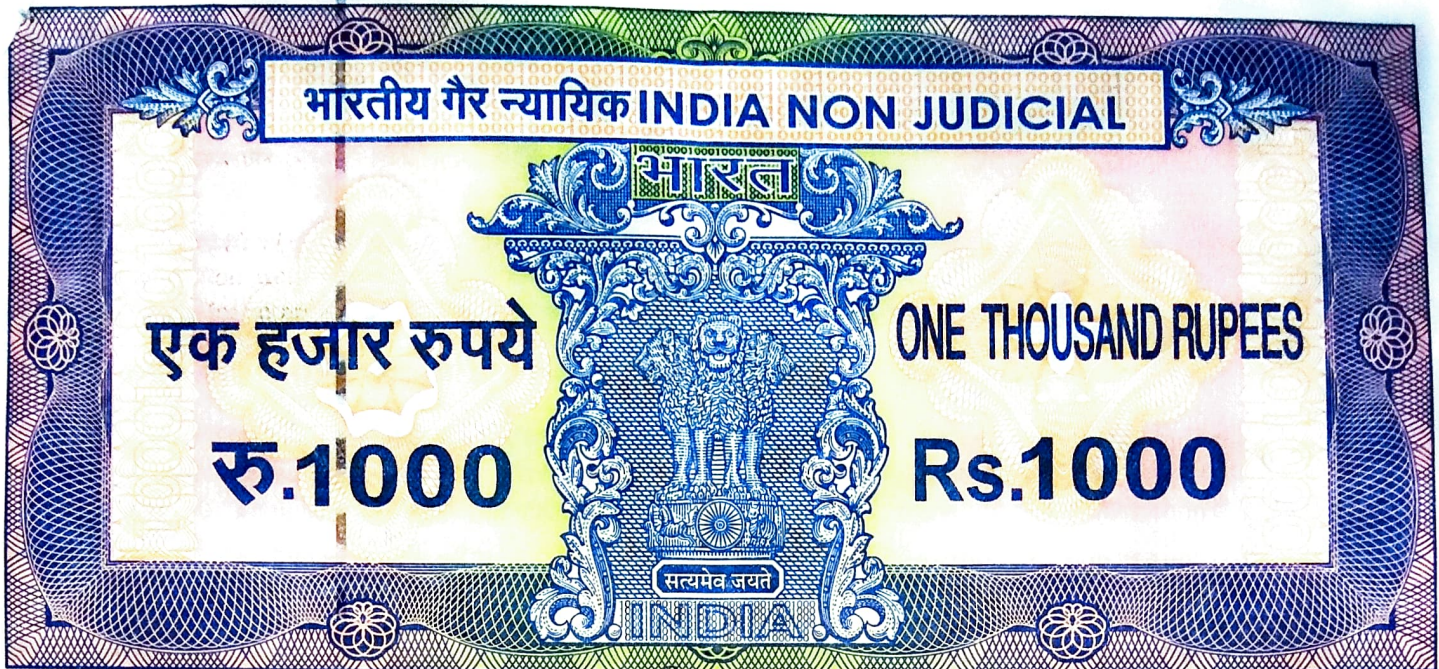

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between your and the Agency shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid until 28 days from the date of expiry of the Defect Liability Period.

Notwithstanding anything contained herein:

- 1. Our liability under the Bank Guarantee shall not exceed Rs. 2,56,000/- (Rs. Two Lakh Fifty Six Thousand Only).**
- 2. This Bank guarantee shall be valid upto 28/07/2020**
- 3. We are liable to pay guaranteed amount or any part thereof under this guaranteed amount or any part thereof under this guarantee only and if you serve upon us a written claim or demand on or before 28/07/2020 along with the Original Bank Guarantee.**
- 4. Advances to be received against the said Bank Guarantee, if any, is to be routed through the customer's account maintained with Andhra Bank.**
