

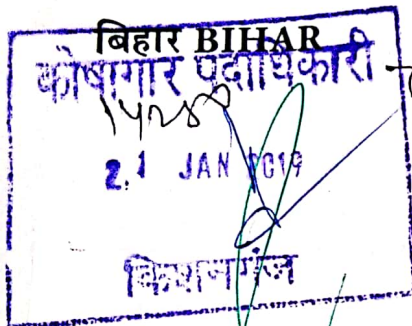
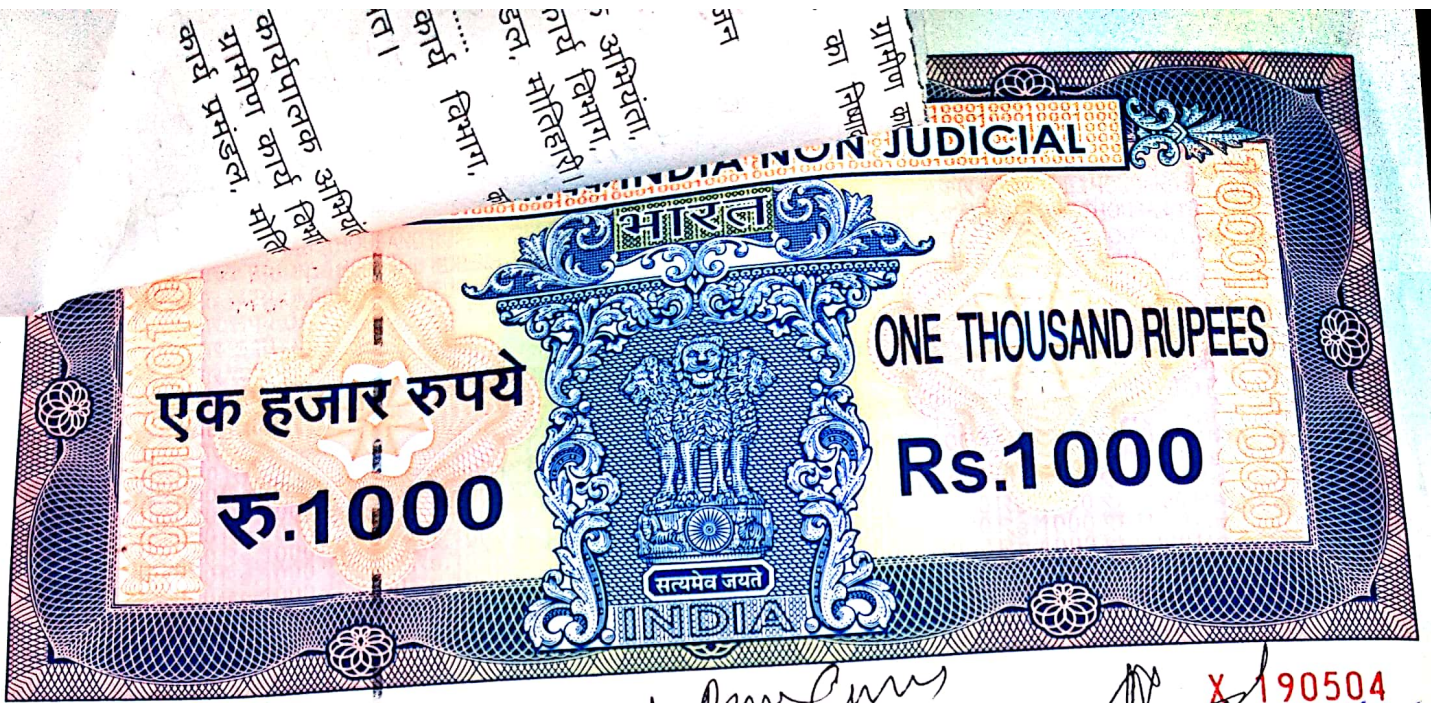

- (iii) We are liable to pay the guarantee amount or any part, there of under this Bank Guarantee only if you serve upon us a written claim or demand on or before (date of expiry of Guarantee i.e. **07.02.2020**).
