We hereby waive the necessity of your demanding the said debt from the contractor before presenting us with the demand.

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between you and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid up to 07.11.2020 (excluding claim period) from the date of expiry of the Defect Liability Period.

Notwithstanding anything contained herein:

Our Liability under this Bank guaranty shall not exceed Rs. 6,48,000/-

This Bank Guarantee shall be valid up to 07.11.2020.

We are liable to pay the guarantee amount or any part thereof under this Bank Guarantee only and only if Employer serves upon Bank a written claim or demand on or before (Excluding claim period)
