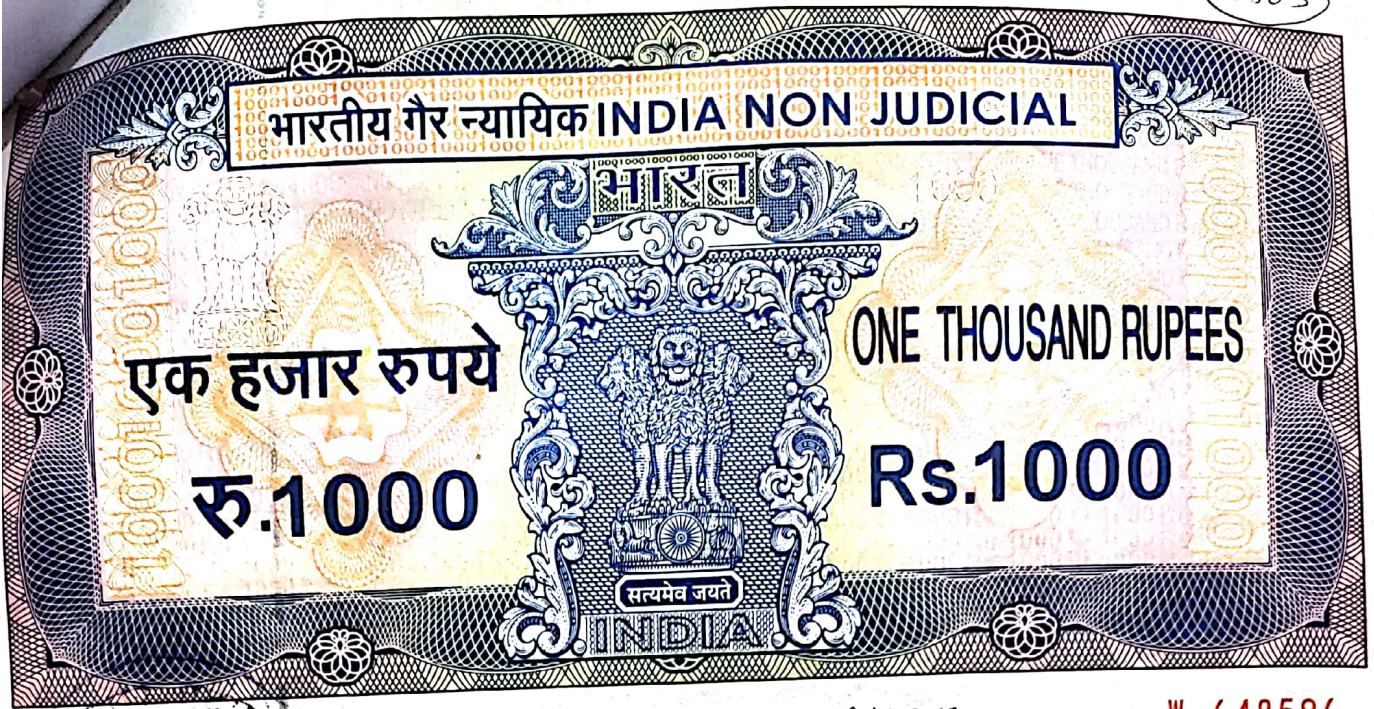

AND WHEREAS it has been stipulated by you in the said Contract that the Contractor shall furnish you with a Bank Guarantee by a scheduled bank for the sum specified therein as security for compliance with his obligations in accordance with the Contract;

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between you and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid until up to 20-10-2020 (a date 45 days after the lapse of Defect Liability Period).

Notwithstanding anything contained herein:

- Our liability under this bank guarantee shall not exceed Rs. 2,38,300/- (Rupees **Two Lac Thirty Eight Thousand Three Hundred only**)
- This Guarantee shall be valid up to 20-10-2020 and
- We are liable to pay the guaranteed amount or any part thereof under this bank guarantee only and only if you serve upon us a written claim or demand on or before 20-10-2020 (including the claim period, if any this should be co-terminus with the period of Bank Guarantee)
