This guarantee shall be valid until up to **24-11-2020** (a date 45 days after the lapse of Defect Liability Period).

- Our liability under this bank guarantee shall not excess **Rs 17,48,000/-** (Seventeen Lac Forty Eight Thousand Only)
- This Guarantee shall be valid up to **24.11.2020** and
