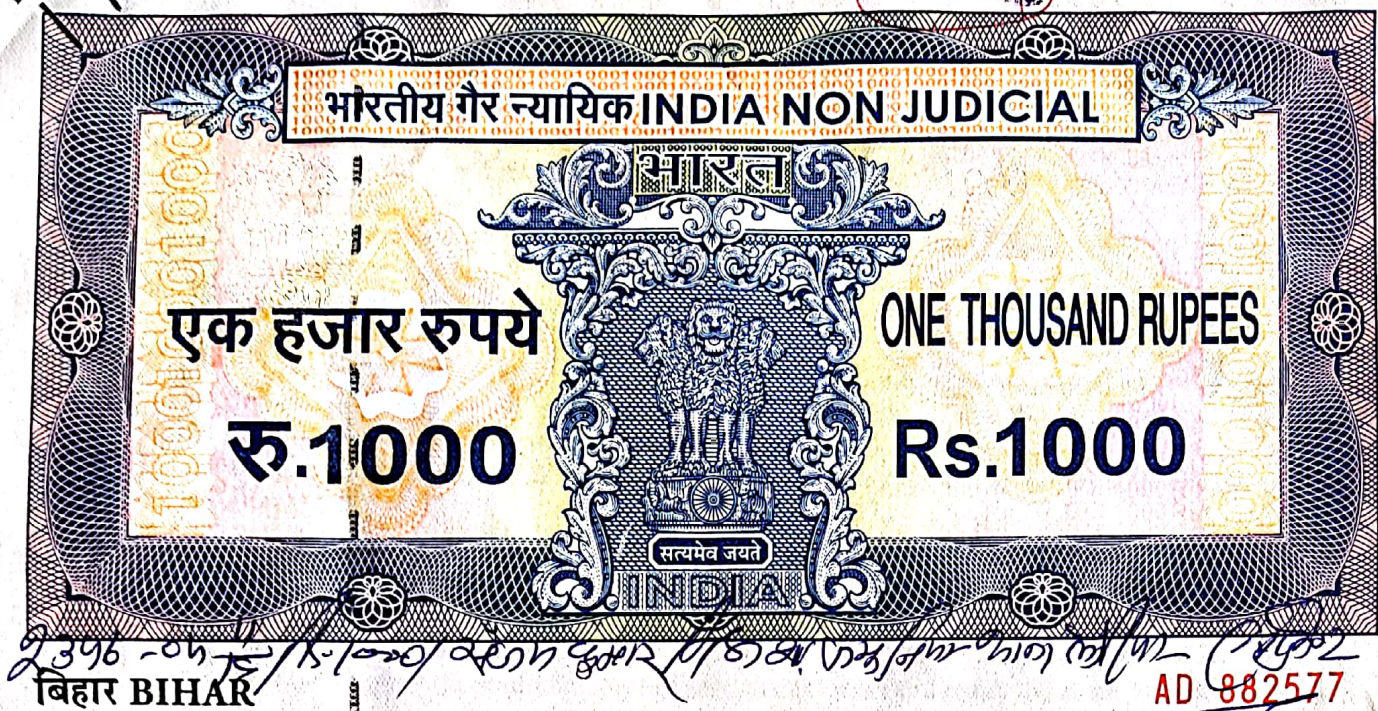

BID SECURITY (BANK GUARANTEE UNCONDITIONAL)

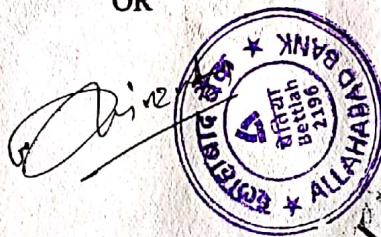
KNOW ALL PEOPLE by these presents that We Allahabad Bank, Bettiah Branch [name of Bank] of India [name of country] having our registered office at NETAJI SUBHASH ROAD, KOLKATA (hereinafter called "the Bank") are bound unto EXECUTIVE ENGINEER RWD WORKS DIVISION, BAGAHA-1 [name of Employer] (hereinafter called "the Employer") in the sum of 2,50,000/- (TWO LACS FIFTY THOUSAND) *for which payment well and truly to be made to the said Employer by the Bank itself, his successors and assigns by these presents.

THE CONDITIONS of this obligation are :

- (1) If after Bid opening the Bidder withdraws his bid during the period of Bid validity specified in the Form of Bid;

OR



- (2) If the Bidder having been notified to the acceptance of his bid by the Employer during the period of Bid validity :
- (a) Fails or refuses to execute the Form of Agreement in accordance with the instructions to Bidders, if required; or
 - (b) Fails or refuses to furnish the Performance Security, in accordance with the instruction to Bidders; or
 - (c) Does not accept the correction of the Bid Price pursuant to Concerned Clause.

We undertake to pay to the Employer up to the above amount upon receipt of his first written demand, without the Employer having to substantiate his demand, provided that in his demand the Employer will note that the amount claimed by him as due to him owing to the occurrence of one or any of the three conditions, (specifying the occurred condition or conditions).

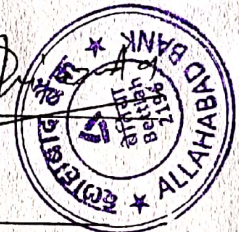

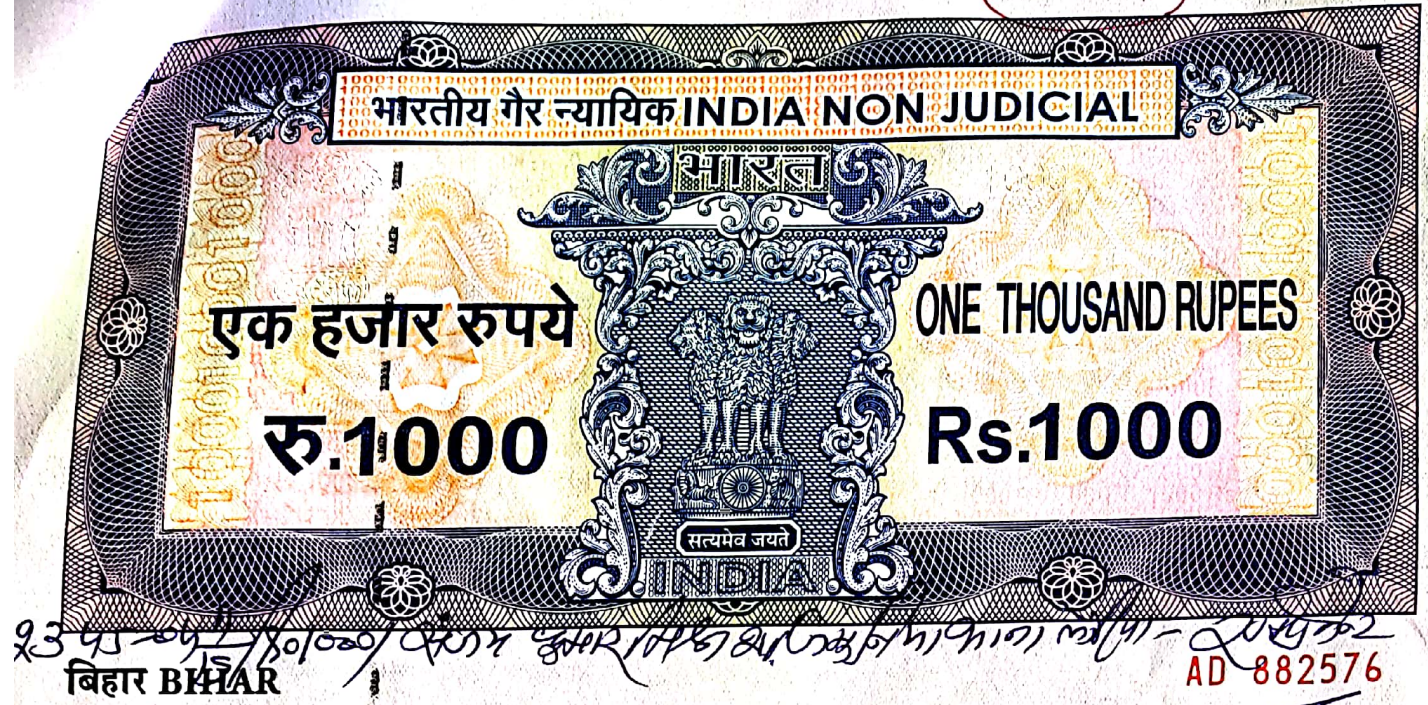

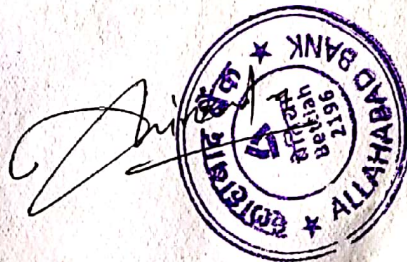

AND WHEREAS we have agreed to give the Contractor such a Bank Guarantee :

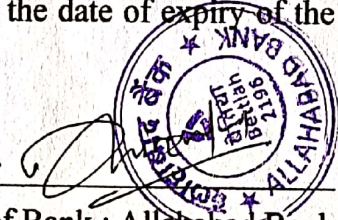
NOW THEREFORE we hereby affirm that we are the Guarantor and responsible to you on behalf of the Contractor, up to a total of **4,65,000/-** [amount of guarantee]* **Four Lacs Sixty Five Thousand Rupees** (in words), such sum being payable in the types and proportions of currencies in which the Contract Price is payable, and we undertake to pay you, upon your first written demand and without cavil or argument, any sum or sums within the limits of **4,65,000/-** [amount of guarantee] as aforesaid without your needing to prove or to show grounds or reasons for your demand for the sum specified therein.

We hereby waive the necessity of your demanding the said debt from the contractor before presenting us with the demand.

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between your and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid until 28 days from the date of expiry of the Defect Liability Period.
