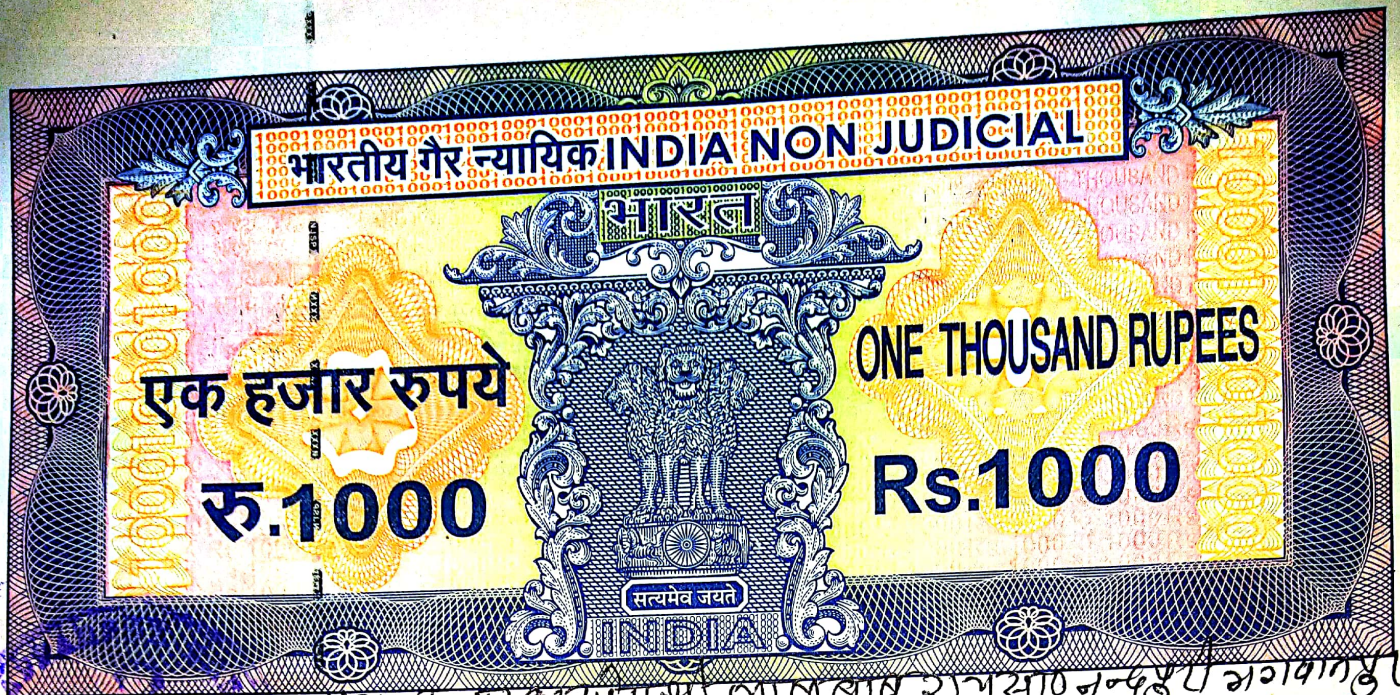

5. This guarantee will not be discharged due to the change in the constitution of the bank or the contractor(s).

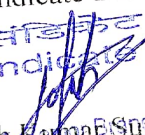
7. **Notwithstanding anything contained herein:**
