Package Name (No.- **RWD MMGSY/HQ/ET/2018-19/11 (SIMRI UCHYA VIDHYALYA TO NAHAS UTTRI TOL)** Hereafter called "the side Agreement") of security deposit for the due fulfillment by the said contractor (s) of the terms and conditions in the said Agreement, on production of a bank guarantee for **292000.00 (Two Lacs Ninety Two Thousands)** we state bank of India (Hereinafter referred two as "The bank") do hereby undertake to pay to the beneficiary and an amount not exceeding **292000.00 (Two Lacs Ninety Two Thousands)** against any loss or damages caused to or suffered or would be caused of suffered by the beneficiary by



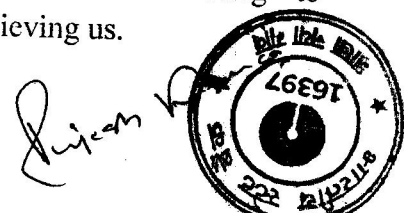
breach by the said contractor(s) of any of the terms of conditions contained in the said Agreement

Any such demand on the Bank shall be conclusive as regards the amount due and payable by the Bank under this guarantee. We State Bank of India, further agree that the guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said agreement and that it shall continue to be enforceable till all the dues of the beneficiary under or by virtue of the said Agreement have been fully paid and its claim satisfied or discharged or till date -----

4. This contract of Bank Guarantee shall remain in operation for the period of 12 Months (Period for which guarantee is required to be mentioned here) only after the date on which this contract is signed by the parties. The demand if only for payable under the terms of this contract is signed by the beneficiary within the said period of 12 months only. The beneficiary may enforce the same pursuant to such demand in any court of Tribunal in accordance with Law.
5. We state Bank of India, further agree with the beneficiary the beneficiary shall have the fullest liberty without our consent and without accepting in any manner our obligation hereunder to vary any of the terms and conditions of the said agreement or to extend time of performance by the said contractor(s) from time to time or to postpone for any time or from time to any of the powers exercisable by the beneficiary against the said contractor(s) and to forbear or enforce any of the terms and conditions relating to the said agreement.

Beneficiary shall, as far possible, assess and quantify the actual Loss damage suffered before invocation and invoke the guarantee accordingly if it was not possible for the beneficiary to furnish the Actual Loss/ damage suffered at the time of invocation, then the bank shall pay the amount in terms of invocation by the beneficiary.
