AND WHEREAS we have agreed to give the Contractor such a Bank Guarantee;

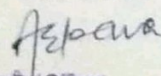

We hereby waive the necessity of your demanding the said debt from the Contractor before presenting us with the demand.

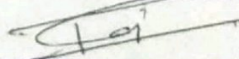
