6. Check balance after transaction written in the passbook and contact postmaster immediately in case of any discrepancy.
7. In case of loss of passbook, report to postmaster immediately.
8. Intimate change of address if any to the postmaster.
9. Do not hand over blank signed withdrawal slip including authorized agents.
10. Do not appoint postmasters or authorized agents for withdrawals of money from your account.
