## BID SECURITY (BANK GUARANTEE UNCONDITIONAL)

KNOW ALL PEOPLE by these presents that We Punjab National Bank Anaith, Ara (name of Bank) of <u>India</u>.

(name of country) having our registered office at Anaith Ara,(her inafter called the 'Bank') are bound unto E.E., R.W.D., Works Division, KISHANGAJ-1 (name of employer) (hereinafter called "the Employer") in the sum of Rs.4,62,000/- (Rs. This Guarantee will remain in force up to and including the date 180 \*\* days after the deadline for submission of Bids as such deadline in stated in the instructions to Bidders or as if may be extended by the Employer, notice of which extensions(s) to the Bank is hereby waived. Any demand in respect of this guarantee should reach the Bank not later than the above date.

- (i) our liability under this Bank Guarantee shall not exceed Rs.4,62,000/- (Rs. Four lakh Sixty two thousand)only
- (ii) this Bank Guarantee shall be valid upto 06.06.2020; and
- (iii) we are liable to pay the guaranteed amount or any part thereof under this Bank Guarantee only and if you serve upon us a written claim or demand on or before 06.06.2020 (date of expiry of guarantee)."
