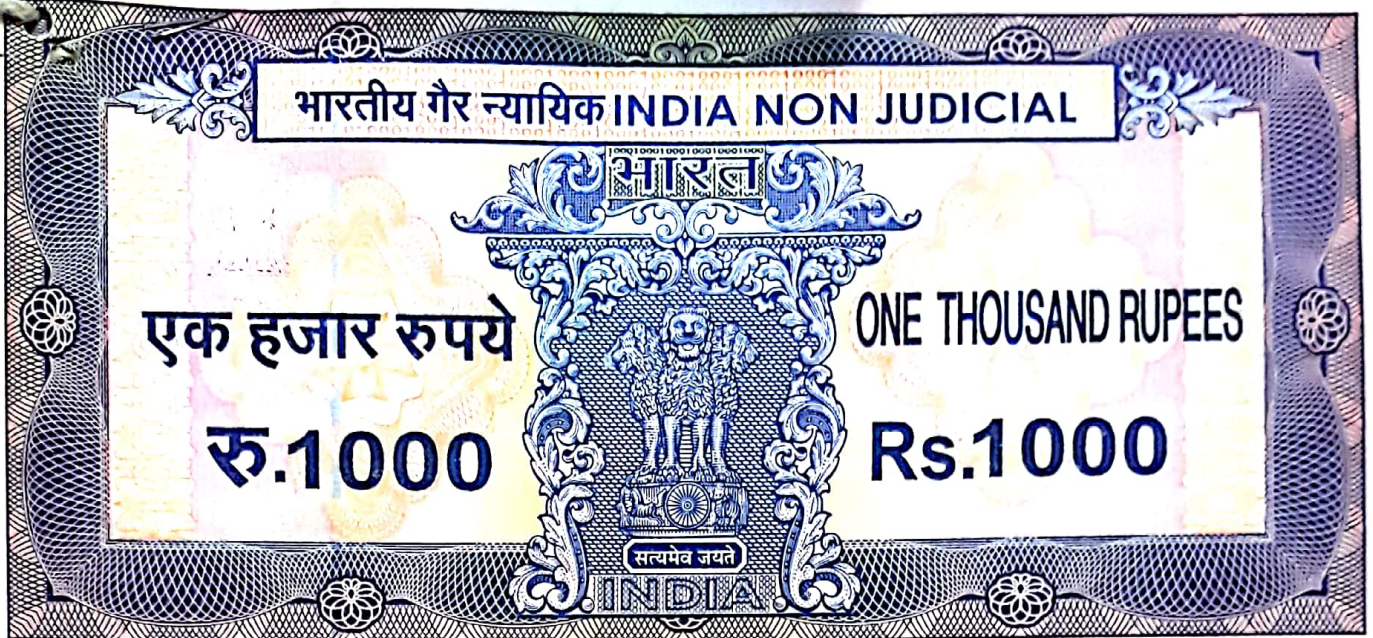

(i) our liability under this Bank Guarantee shall not exceed

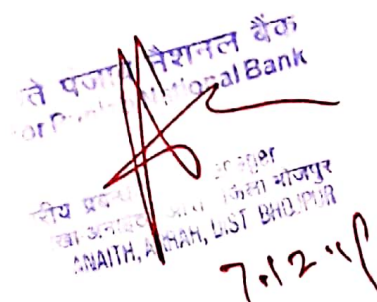
