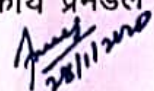

KNOW ALL PEOPLE by these presents that We State Bank of India, having our registered office at Main Branch, Dist. Purnea-854301 of India (hereinafter called "the Bank") are bound unto Executive Engineer, RWD Works Division, Dhamdaha. (hereinafter called "the Employer") in the sum of Rs. 2,46,000/- (Rupees Two Lac Forty Six Thousands Only) for which payment well and truly to be made the said Employer by the Bank itself, his successors and assigns by these presents.

 - (b) Fails or refuses to furnish the Performance Security, in accordance with the Instruction to Bidders; or
 - (c) Does not accept the correction of the Bid Price pursuant to Clause 27;

We undertake to pay to the Employer up to the above amount upon receipt of his first written demand, without the Employer having to substantiate his demand, provided that in his demand the Employer will note that the amount claimed by him is due to him owing to the occurrence of one or any of the three conditions (specifying the occurred condition or conditions).
