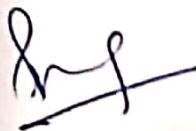

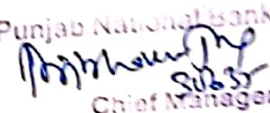
1. If after Bid opening the bidder withdraws his bid during the period of bid validity specified in the Form of bid.
