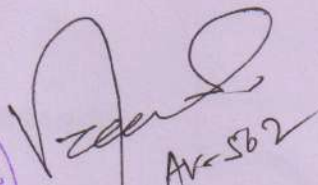
"not withstanding anything contained herein:
