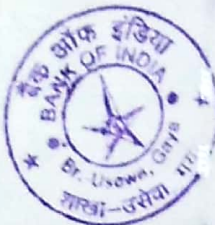
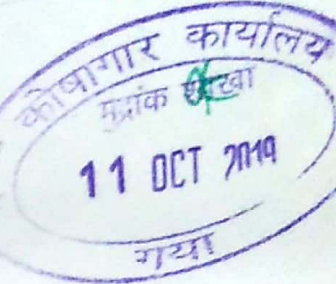

Acting through The Executive Engineer ,RWD,Work Division,Tekari (Project Incharge & Address of the Project) WHEREAS Samafula devi vill. – Bareni, P.O. +P.S. – Cherki, Dist. –Gaya (Bihar) (Name and address of contractor) (hereinafter called “the contractor”) has undertaken in pursurance of contract No..... dated. to execute construction of Road and CD works with Mentenance for Tender Group No. 12PMGSY-108 in Gaya District (name of contract and brief description of works) (hereinafter called “the contractor”).

AND WHERE it has been stipulated by you in the said Contract that the contractor shall furnish you with a bank Guarantee by a sechdule bank for the sum specified therein as security for compliance with his

We further agree that no change or addition to or other modification of the terms of the contract of the works to be performed there under or any of the contract documents which may be made between you and the contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid upto 23/10/2012 (a date 45 days after the lapse of Defect Liability Period).
